Applicants who are offered admission (subject to verification of documents) in the second admission list of PGDCSL are hereby notified that the admissions to the course will commence from 8th December, 2022 at 10:00 AM to 9th December, 2022 11:59 PM. The applicants are required to upload the following documents on the DU PG admission portal for verification:

- Class X Certificate (Marks sheet or certificate) indicating date of birth and Parents' names* (The names of applicants claiming reservation under OBC/EWS/ SC/ST /CW/ PwD must match with the names that appear on the corresponding reservation certificates; similarly their parents' names must match in both sets of certificates).
- Consolidated Mark Sheet/ Degree/ Certificate of qualifying examination on the basis of which the candidate is seeking admission i.e. proof of study of five compulsory subjects: Programming, Networking, Database Management, Operating Systems, Data Structure.
- OBC/EWS/ SC/ST /CW/ PwD Certificate (in the name of the Applicant) issued by the competent authority.
- OBC (Non-Creamy Layer) Certificate (in the name of the Applicant) issued by the competent authority in the format prescribed and issued on/after date specified by the admission branch of the University of Delhi, and wherein the caste is in the OBC central list issued by <http://ncbc.nic.in>. The validity of the non-creamy layer certificate shall be for the financial year 2021-2022, issued after 31st March, 2022.
- EWS Certificate from competent authority certifying that the applicant can claim reservation under this category.
- Mark sheets showing the Programming, Networking, Database Management, Operating Systems, Data Structure, papers have been passed by the candidate.
- Candidates seeking admission under EWS/ OBC/ SC/ ST category should have the valid certificate in their own name on the day of admission.

Note: In case of any seat remaining vacant after admissions of second list are finished, the third list shall be issued by ICSL.

The following applicants are provisionally offered admission in PGDCSL in second admission list subject to verification of their documents and payment of the course fees before 10th December, 2022 up to 11:59 PM.
